I grant the rights hereunder whether or not I am selected to participate in the Program in any manner whatsoever. I release Releasees from any and all liability arising out of Releasees' recording or use of my Likeness and/or the Materials. I agree not to make any claim against Releasees as a result of the recording or use of my Likeness and/or the Materials (including, without limitation, any claim that such recording or use invades any right of privacy and/or publicity). I understand that I will not be paid any money for giving Releasees these rights, or for signing this Application. This agreement shall be governed by and construed in accordance with the laws of the State of California.

I acknowledge that materials (or portions thereof) developed, created, acquired, licensed or otherwise obtained by Producer, or third party materials to which Producer has access, may be similar or identical to the Materials (or portions thereof) I submit to Producer. I agree that I will not be entitled to any compensation because of the use of any such similar or identical material. I hereby waive, and agree that I will never make, any claim or demand or bring any action against Producer in connection with the use of the Material. In this connection, I hereby release and absolutely and forever discharge Producer of and from any and all claims, damages, legal fees, costs, expenses, debts, actions and causes of action of every kind and nature whatsoever, whether now known or unknown, suspected or unsuspected, asserted or unasserted, which I now have, or at any time heretofore ever had or which I may have in the future, against Producer which in any way arise out of or in connection with the Materials.
